#### Dues & Donations

Base Dues - are **\$554 per adult member.**

Community Support Contribution - the membership committee suggests that everyone contribute \$18 to help support those who cannot afford full dues.

Fair Share Additional Dues - we ask that those who are financially in a position to do so contribute an additional amount as part of their dues. We have a recommended amount listed on the attached table, but what you give is up to you and your circumstances.

#### Deductions & Discounts

א	As an incentive for you to send your forms in before the new fiscal year begins, we offer a \$10 reduction for each members whose documents are <b>received</b> before June 30 2011.
ב	As an incentive to have you pay your dues and donations is a single payment with no installment billing, we offer a \$10 discount for each member.
ג	In recognition of our diverse family units, we offer a discount of \$10 per family joining together.
<b>If you cannot afford base dues</b> and your circumstances fit one of the three categories below and the discount better enables you to be a member, choose <b>one</b> of the discounts of <b>\$249</b> for each individual.	
ד	Full Time Student - you are a full time student and cannot afford base dues.
ה	Young Professional or Senior Discount - You are a young professional under 25 and just getting started; or over 67 and on a limited income, and cannot afford base dues.
ו	Geography Discount- You live outside the Washington/Baltimore Metropolitan Area and cannot fully avail yourself of the services of the congregation, but wish to support it through your membership and cannot afford base dues.
ז	Dual synagogue memberships - if you need to belong to another congregation for Hebrew school for your children, or for any other reason, but you still want to maintain your membership with Bet Mishpachah. Contact the VP Membership to make arrangements.
ח	Financial Constraints Adjustment - If after utilizing the above discounts and incentives, your financial situation does not allow you to pay base dues, we still want you as a member. Discuss any additional discount you need with the VP Membership and enter the additional discount amount(s) here.

#### Payment Information

You can pay in full and take advantage of the discount or you can pay in installments.

You can pay by check, EFT from your bank, or credit card. We prefer checks or EFT, but you can use either MasterCard or VISA. The reason for our preference is that the credit card companies charge fees we have to pay that cost us about 4% of the amount charged.

If you have internet banking arrangements, you can set up EFT payments in full or installments. EFT payments should be sent to **BET MISHPACHAH, Dept 0520, Washington, DC 20073-0520** in the memo section indicate **Dues & Donations**

If you choose to pay by credit card please print clearly using block letters and provide all the information requested. **Be sure to indicate the amount to be charged at this time in the box above the card information.**

Installment payments can be paid by check, EFT or charged to your Credit Card

Please provide us with an e-mail address at which you would like to receive your monthly statements. If you do not have an e-mail account, we will send statements via US Mail to the address listed at the top of the invoice. You will receive a statement each month, but you can pay on whatever schedule you prefer, monthly, quarterly, randomly. **We ask that payment be complete by April 2012.**

If you choose credit card installments, **it is important to indicate the amount to be charged NOW to your in the box above the card information.** The remaining balance will be divided by the number of installments you choose, not exceeding the number of full months remaining through April 2012, and processed monthly. If you would like a different schedule, contact the Treasurer and you can make individual arrangements. Please be sure your card does not expire before the final payment.
